### THEME OF THE MEETING

### Kinesiology's Social Justice Imperative

Kinesiology is a field focused on physical activity and its impact on health, society, and quality of life. But do *all* people have equal opportunities to access and experience physical activity? Do physical activity settings allow people to freely express themselves? Are the benefits of physical activity universally shared by *all* people? If the answer to these questions is "no," then these questions demand not only our immediate attention, but also our collective action. During the National Academy of Kinesiology's 90<sup>th</sup> anniversary meeting these questions – among others – will be explored using a multitude of investigative approaches that display a "cell to society" orientation whereby multiple subdisciplines, including the integration of subdisciplines, contribute to the discourse. As stewards of the discipline, we are all part of something larger than ourselves with a duty and obligation to "*Pass it on*." What we pass on and to whom is important. As such, the speakers may be seeking to not merely raise awareness, increase knowledge, or point out problems, but to genuinely move the needle by disrupting the status quo through more intentional efforts aimed at overcoming social injustices that have been observed.

This year we will be celebrating the Academy's 90<sup>th</sup> anniversary meeting. We will also be revealing the results of the Academy's fourth ever doctoral program review (i.e., January 1, 2015 – December 31, 2019). While tangential to the meeting's theme, these are important milestones in our organization's history. The former will allow us time to reflect on where we come from and what we are part of, whereas the latter will help us understand contemporary doctoral education, which is a key element in the development of our future.
